Introduction:

The course intends to familiarize the participants with the issues relating to "Business of Insurance in DoP".

Course Description:

PLI is the oldest Life Insurance Scheme guaranteed by the Govt. of India. It was established in 1884. PLI has grown substantially from a few hundred policies in 1884 to 42,83,302 policies, as on 31.03.2010. PLI is an exempted insurer under section 118(C) of the Insurance Act of 1938. It is also exempted under section 44(d) of LIC Act, 1956.

Employees of Central and State Govt., PSUs, Nationalized Banks, Govt. Aided Institutions, Defence Services, Gramin Dak Sewak, Regional Rural Banks and Govt. Universities etc. are eligible to take PLI policies.

As this scheme was started for the welfare of the family of defence personnel and Govt. employees, so it is running on the principle of "Low Premium and High Bonus".

This one day course will be a unique opportunity for the participants to enhance their knowledge about Postal Life Insurance.

- (a) Overview of Postal Life Insurance.
- (b) How to calculate surrender value.
- (c) How to calculate death benefits in case of death.
- (d) How to settle death claims.
- (e) How to revive the policies.


